#### 1. PURPOSE

The purpose of these terms of reference is to request suitably qualified service providers to submit a comprehensive proposal and quotations to Sedibeng District Municipality (SDM) for the replacement of all normal water taps with push button taps throughout the main building of SDM and the Mayors Parlour on the corner of Beaconsfield Avenue and Leslie Street, Vereeniging.

#### 2. SCOPE OF WORK

SDM requires the services of suitably qualified service providers to conduct an assessment, and thereafter submit detailed proposals for the replacement of normal taps with push button taps throughout the entire main building and Mayors Parlour of Sedibeng. A total of approximately 61 taps and 19 mixers situated in kitchens and bathrooms must be replaced. There will be some taps which will only be blanked off. Some taps are basin mounted and some are wall mounted. All old taps and mixers which must be removed must be discounted against the price of the new taps and this must be clearly shown on the tender and subsequent invoice.
